The Act aims to provide for institution of provident funds, family pension funds and deposit linked insurance funds for the employees in the factories and other establishments.

Labour Welfare Board Act: -Maharashtra, Gujarat Labour Welfare Board has become effective in the year 1953 and is applicable to all the companies in the state that has 5 or more persons employed, who are considered contract labours as per the Act.

Shop & Establishment: - Any citizen who wishes to open new shop or a commercial establishment wants to commence its business within the jurisdiction of Government of Maharashtra, has to register itself under The B Shops and Commercial Establishment Act, 1948.

Contract Labour Act 1970: - An Act to regulate the employment of contract labour in certain establishments and to give for its abolition in certain circumstances and for matters connected there with. It applies to every establishment in which twenty or more workmen are employed or were employed on any day of the preceding twelve months as contract labour; to every contractor who employees or who employed on any day of the preceding twelve months twenty or more workmen:
